

TERMS & CONDITIONS



REG CHARITY NUMBER: 1174092

- 1 - This competition is open to persons aged 18 years, you must be a resident of the UK, Isle of Man or the Channel Islands. Proof of age may be required
- 2 - Entry to the competition is £10/entry, multiple entries to the competition are acceptable but will be charged at £10 each time.
- 3 - Registering your interest on our website does not mean you have entered the competition. You will be sent a form to complete your scores, only when we have received this and payment will you be entered into the competition.
- 4 - Players will be deemed to have accepted these terms and conditions and agreed to be bound by them when entering this competition. These terms will apply for the duration of the competition starting from June 13th.
- 5 - Points will be scored as follows: 5 points for each correct score predicted in each of the games. Players will receive 3 points for a correct result.
- 6 - Round one will be open until 23:59 on June 13th, we will need the predictions for all the group games shown on the entry form. Any missed games will be classed as an incorrect score.
- 7 - A further four rounds will be emailed to the entrant, 1 for the last 16, 1 for the quarter finals, 1 for the semi finals and 1 for the final/3rd placed playoff. Entry dates for these will close at 23:59 of the day before the first listed game.
- 8 - Entry forms can be changed up until the deadline for that round.
- 9 - The prizes will be split as follows:
 - 1st Place (the highest total number of points after the World Cup Final) = £150
 - 2nd Place (the next highest total of points after the world cup final) = £100
 - 3rd Place (the next highest total of points after the World Cup Final) = £50
- 10 - No other prizes are on offer for this competition.
- 11 - Each player will be asked to fill out two tie breakers on there first entry form - total number of goals scored in the World Cup and Total number of Yellow Cards in the World Cup. Should two players finish on the same number of points we will go to the first tie breaker (goals). Should this not split the players then we will move to the second tie breaker (yellow cards). If this has still not determined a winner the prize will be split equally.
- 12 - Scores will be determined by the results shown on FIFA's official website.
- 13 - Results at the end normal time (90 minutes) will count as the score for that fixture, if any game is abandoned or not completed, this game will be void and no points will be scored.
- 14 - The Charity will not be held liable for any prizes that do not reach the winners for reasons beyond its reasonable control.
- 15 - Winners will be notified by email within 5 working days of the World Cup Final, it is the responsibility of the entrant to ensure their contact details are up to date with the charity. Please allow 30 days for payment of any prize money.
- 16 - Trustees or anyone else directly connected with the competition may not enter.
